**MSC/Trial Prep:** Get help on preparing for your Mandatory Settlement Conference and/or Trial, including how to complete Financial Disclosure Documents and the Settlement Conference Statement.

**(DISSO) Default Judgment:** When filing a judgment when the other side has NOT responded to the petition.

**(DISSO) Judgment by Agreement:** When a Petition and Response have been filed; and both parties are in complete agreement on all issues (custody/visitation, support, and property/debt division).

**(EPR) Paternity Default Judgment:** For people who are not married. If the other side has NOT filed a response to the **Paternity Action** you can get a Default Judgment.

**Judgment Clinic:** Review completed default judgments; default judgments with agreement or judgments by agreement. **Bring** all of the paperwork filed & all orders made in your case. You **MUST** bring a packet to the class.

**Petition Packet / Response Packet**

**(EPR) - Petition/Response:** Assistance for parties who are not married and are starting or responding to a **Paternity Action**.
