Self-Represented Orientation: This class is a must for people representing themselves in court. Reduce the uncertainty of handling your own case by learning what is expected of you and how to successfully navigate the court system.

Divorce Petition/Response: Required for people starting or responding to a Divorce/Legal Separation; includes complete instruction on filling-in all of the required paperwork, and an in-depth review of the court process.

(EPR) - Petition/Response: Required for people who are not married and are starting or responding to a **Paternity Action**, includes on filling-in all of the required paperwork, and an in-depth review of the court process.

(EPR) – Default Judgment: All cases require final paperwork called a Judgment. If the other side has NOT filed a response to the **Paternity Action** you can get a Default Judgment. You **MUST** bring a packet to the class.

Child Support-Family Law Assistance Clinic: Help with child/spousal support issues; paternity; DCSS cases; custody/visitation; obtaining or modifying court orders; form review.

(DISSO) Default Judgment: All cases require final paperwork called a Judgment. If the other side has NOT filed a Response to the Divorce/Legal Separation you can get a Default Judgment. To attend this class, **you must bring** all of the paperwork you have filed, **AND** you must have completed your Income and Expense, Schedule of Assets and Debts, and Declaration of Disclosure.

(DISSO) Judgment by Agreement: Required when both a Petition and Response have been filed & both parties are in complete agreement on all issues (custody/visitation, support, and property/debt division).
