WORKSHOPS

Petition/Response Workshop:

Instructor will provide a basic understanding of the Divorce/Legal Separation process. Form assistance will be provided during the workshop to both the Petitioner and Respondent.

Note: Spanish class *may exceed* 2.5 hours.

EPR – (Establish Parental Relationship/Paternity):

Instructor will provide a basic understanding of how to obtain a Judgment to Establish a Parental Relationship. Form assistance provided.

Order to Show Cause Workshop:

Instructor will provide assistance in completion of the appropriate paperwork for obtaining temporary orders on issues such as child custody/visitation, support, injunctions with an explanation of what to expect in court.

Judgment Workshop: ALL CASES require FINAL PAPERWORK known as a JUDGMENT.

If finishing a case by agreement, both parties must be present. PLEASE bring all filed paperwork with you to the class and a copy of your “case print”, available from the Court Clerk. For Divorce, Legal Separation, Nullity: You must have completed Income & Expense, Schedule of Assets and Debts prior to attending this workshop.

Workshops are held every Thursday as follows: 8 am – 10 am, 10 am – noon, 1 pm – 3 pm, and 3 pm – 4:30 pm

Child Support Clinic: Will provide assistance with DCSS forms/cases and customers who need advice and want to obtain or modify a child support order.

MSC (Mandatory Settlement Conference):

Will provide instruction on how to prepare for your Mandatory Settlement Conference, including how to complete your Financial Disclosure Documents and the Settlement Conference Declaration. Please arrive no later than 1:30 pm for workshop registration.
