### FAMILY LAW WORKSHOP DESCRIPTIONS

**Divorce Petition/Response:** Required for people starting or responding to a Divorce/Legal Separation; includes complete instruction on filling-in all of the required paperwork, and an in-depth review of the court process.

**Default Judgment:** Required when filing a judgment when the other side has **NOT** responded to the petition. **You must bring** all of the paperwork you have filed.

**Judgment by Agreement:** Required when both a Petition and Response have been filed & **both parties are in complete agreement on all issues** (custody/visitation, support and property/debt division).
