For “Family Law Triage” & “Child Custody/Support Clinic”, sign-up begins at 7:30am and will remain open until the list for the day reaches capacity. You may be placed on the afternoon list if morning services have reached capacity.

FAMILY LAW TRIAGE: Brief assistance in procedural guidance (i.e. spousal support, child support/custody/visitation, dissolution, legal separation, parentage, etc.); OR in reviewing your family law forms that are at least 85% to 90% complete (**WE DO NOT COMPLETE FORMS OR WRITE, READ OR REVIEW DECLARATIONS FOR YOU.**)

CHILD CUSTODY & CHILD SUPPORT CLINIC: Assistance for parties beginning, modifying/settling disputes about child support, custody and/or visitation in a family law case.

Sign-up for the workshops begin at 7:30am and close once the workshop begins or when the workshop reaches capacity. Space is limited to 15 participants so please arrive early - No Exceptions! Children are not permitted in workshops (No se permite traer niños a los talleres o clínicas).

ORIENTATION WORKSHOP: This class is necessary for people representing themselves in court. Learn what it means to be a self-represented litigant, and how you can navigate the court system.

DISSO WORKSHOP: Get help starting or responding to a Divorce, Legal Separation or Nullity in the County of Riverside, State of California, only.

MSC/TRIAL PREP WORKSHOP: Get help on preparing for your Mandatory Settlement Conference and/or Trial, including how to complete Financial Disclosure Documents and the Settlement Conference Statement.

JUDGMENT CLINIC: On Thursdays, by appointment only. This clinic is only for litigants who have an open family law case and are ready to finalize the case. Please email your case no. to: SWJCFamilyLawWorkshop@riverside.courts.ca.gov to determine whether your case has met the requirements for assistance. If so, you will be scheduled an appointment. If not, you will be directed to another workshop/clinic to review your case.
