For “Family Law Triage” & “Child Custody/Support Clinic”, sign-up begins at 7:30am and will remain open until the list for the day reaches capacity. You may be placed on the afternoon list if morning services have reached capacity.

FAMILY LAW TRIAGE:

Brief one-on-one assistance in procedural guidance (i.e. child/spousal support, child custody/visitation, dissolution, legal separation, nullity, parentage and domestic violence restraining orders); OR in reviewing your family law forms that are at least 85% to 90% complete.

CHILD CUSTODY & CHILD SUPPORT CLINIC:

Assistance for parties beginning, modifying or settling disputes about child support, custody and/or visitation in any family law case.

DISSO WORKSHOP

Sign-up begins at 7:30am and closes at 8:30am; or 12:30pm and closes at 1:30pm; or when workshop reaches capacity.

Get help starting or responding to a Divorce, Legal Separation or Nullity of Marriage in the County of Riverside, State of California, only.

MSC/TRIAL PREP WORKSHOP

Sign-up begins at 7:30am and closes at 8:30am; or 12:30pm and closes at 1:30pm; or when workshop reaches capacity.
