Pull a ticket for "Assistance Center/Self-Help"; then "Workshops/Clinics"

FAMILY LAW TRIAGE: Brief one-on-one assistance in procedural guidance (i.e. child/spousal support, child custody/visitation, dissolution, legal separation, nullity, parentage and domestic violence restraining orders); OR in reviewing your family law forms that are at least 85% to 90% complete. (NOTE: You CANNOT attend this clinic to obtain help in preparing your family law judgment packages nor correcting a rejected package. It does not matter if your forms are almost complete; the proper clinic for you to attend to do this is the "Judgment Clinic". Please see schedule to the right.)

DISSO WORKSHOP (Dissolution - Petition/Response): Get help starting or responding to a Divorce, Legal Separation or Nullity of Marriage.

RFO WORKSHOP (Request for Order): Get help getting a hearing on calendar to initiate or modify court orders for child support, child custody, child visitation, spousal support and/or other orders in your family law case.

MSC/TRIAL PREP WORKSHOP (Mandatory Settlement Conference): Get help on preparing for your Mandatory Settlement Conference and/or Trial, including how to complete Financial Disclosure Documents and the Settlement Conference Statement.

CHILD CUSTODY/SUPPORT CLINIC: (one-on-one assistance) Assistance for parties beginning, modifying or settling disputes about child support, custody and/or visitation in any family law case. (*Formerly known as "EPR Clinic")
