**COURT'S PROBABLE CAUSE FINDINGS AND ORDERS**

**ORDER OF THE COURT:**

- Court does not find probable cause to support a revocation, vacates any hearing dates, and returns the supervised person to supervision on the same terms and conditions. The supervising agency must notify the prosecutor, supervised person, and the supervised person's counsel (if any) of the dismissal.
- Court finds probable cause to support a revocation and summarily revokes supervision and tolls the running of the supervision period; Court appoints counsel.
- Bench Warrant to issue. Bail set at \$ No Bail.
