The appointment of the conservator may also take away some or all of the following rights: The right to refuse treatment related to your being gravely disabled; The right to refuse routine medical treatment; The ability to possess a driver's license or to operate a motor vehicle; The right to enter into contracts; The right to vote; The right to possess a firearm. You have a right to appear at the hearing and oppose the petition. You have the right to hire an attorney of your choice
