You have 30 CALENDAR DAYS after this form was served on you to file a written response at this court and have a copy served on the plaintiff. A letter or phone call will not protect you. Your written response must be in proper legal form if you want the court to hear your case. There may be a court form that you can use for your response. You can find these court forms and more information at the California Courts Online Self-Help Center (www.courtinfo.ca.gov/selfhelp). If you cannot pay the filing fee, you may ask that fees be waived. You can find the court form to request a fee waiver at www.courts.ca.gov/documents/fw001.pdf. If you do not file your response on time, you may lose the case by default, and your wages, and property may be taken without further warning from the court.

There are other legal requirements. You should review the documents you originally received for more information on your legal obligations and the nature of the claims against you. You may want to call an attorney right away. If you do not know an attorney, you may want to call an attorney referral service. If you cannot afford an attorney, you may be eligible for free legal services from a nonprofit legal services program. You can locate these nonprofit groups at the California Legal Services website (www.lawhelpcalifornia.org), the California Courts Online Self-Help Center (www.courtinfo.ca.gov/selfhelp), or by contacting your local court or county bar association.
