**THIRD AMENDED
GENERAL ORDER RE:
IMPLEMENTATION OF EMERGENCY RELIEF AUTHORIZED PURSUANT TO
GOVERNMENT CODE SECTION 68115 BY CHAIR OF JUDICIAL COUNCIL**

Exercising the authority granted under Government Code section 68115 and the April 1, 2020 Order (“Order”) of Chief Justice Tani G. Cantil-Sakauye, Chair of the Judicial Council of California, issued in response to the March 26, 2020, request for an emergency order made by the Superior Court of Riverside County (“Court”),

This Court **HEREBY FINDS AND ORDERS AS FOLLOWS:**

1. For purposes of computing time for filing papers with the Court under Code of Civil Procedure sections 12 and 12a, all days from April 6, 2020 to April 24, 2020, inclusive, are deemed holidays (Gov. Code, § 68115(a)(4));

2. For purposes of computing time under Penal Code section 825, and Welfare and Institutions Code sections 313, 315, 334, 631, 632, 637, and 657, all days from April 6, 2020 to April 24, 2020, inclusive, are deemed holidays (Gov. Code, § 68115(a)(5));

3. With the concurrence of the Presiding Judge, the Court may order that sessions be held anywhere in the county, including in correctional and juvenile detention facilities, from March 26, 2020 to April 24, 2020, inclusive (Gov. Code, § 68115(a)(1));

1 4. Any judge of the Court may extend by not more than 30 days the duration of any
2 temporary restraining order that would otherwise expire on from April 1, 2020 to April 24, 2020,
3 inclusive, because the emergency condition described in the Order prevented the Court from
4 conducting proceedings to determine whether a permanent order should be entered (Gov. Code,
5 § 68115(a)(7));

6 5. In cases in which the statutory deadline otherwise would expire from March 26,
7 2020 to April 24, 2020, inclusive, any judge of the Court may extend the time period provided in
8 section 313 of the Welfare and Institutions Code within which a minor taken into custody pending
9 dependency proceedings must be released from custody to not more than 7 days (Gov. Code,
10 § 68115(a)(11));

11 6. In cases in which the statutory deadline otherwise would expire from March 26,
12 2020 to April 24, 2020, inclusive, any judge of the Court may extend the time period provided in
13 section 315 of the Welfare and Institutions Code within which a minor taken into custody pending
14 dependency proceedings must be given a detention hearing to not more than 7 days (Gov. Code,
15 § 68115(a)(11));

16 7. In cases in which the statutory deadline otherwise would expire from March 26,
17 2020 to April 24, 2020, inclusive, any judge of the Court may extend the time periods provided in
18 sections 632 and 637 of the Welfare and Institutions Code within which a minor taken into custody
19 pending wardship proceedings and charged with a felony must be given a detention hearing or
20 rehearing to not more than 7 days (Gov. Code, § 68115(a)(11));

21 8. In cases in which the statutory deadline otherwise would expire on from April 16,
22 2020 to April 24, 2020, inclusive, any judge of the Court may extend the time period provided in
23 section 334 of the Welfare and Institutions Code within which a hearing on a juvenile dependency
24 petition must be held by not more than 15 days (Gov. Code, § 68115(a)(12)); and

25 9. In cases in which the statutory deadline otherwise would expire from March 26,
26 2020 to April 24, 2020, inclusive, any judge of the Court may extend the time period provided in
27 section 657 of the Welfare and Institutions Code within which a hearing on a wardship petition for
28 a minor charged with a felony offense must be held by not more than 15 days (Gov. Code,

1 § 68115(a)(12)).

2 This order does not nullify or repeal any prior order of this court. In the event that this
3 order conflicts with any other order of this court, the order that provides to the court the power to
4 extend existing deadlines the longer period of time shall control.

5 THIS ORDER IS EFFECTIVE IMMEDIATELY.
