**NOTICE OF  
COURT SERVICES FEE INCREASE**

**EFFECTIVE MONDAY, JANUARY 1, 2020**

Please take note that certain Court Services Fees will increase effective January 1, 2020.

The following Court Services fees will increase from \$25 to \$40:

- Issuing a writ of attachment, a writ of mandate, a writ of execution, a writ of sale, a writ of possession, a writ of prohibition, or any other writ for the enforcement of any order or judgment.
- Issuing an abstract of judgment
- Issuing a certificate of a satisfaction of judgment that has been recorded in a court's register of actions.
- Certifying a copy of any paper, record or proceeding on file in the office of the clerk of the court.
- Taking an affidavit, except in criminal cases or adoption proceedings.
- Acknowledging any deed or other instrument.
- Recording or registering a license or certificate, or issuing a certificate in connection with a license, required by law, for which a charge is not otherwise prescribed.

Additionally, the following Court Services fees will increase from \$30 to \$45:

- Issuing an order of sale;
- Receiving and filing an abstract of judgment rendered by a judge of another court and subsequent services based on it, with certain exceptions;
- Filing a confession of judgment;
- Filing an application for renewal of judgment;
- Issuing a commission to take a deposition in another state or place, or issuing a subpoena to take a deposition in California for purposes of a proceeding pending in another jurisdiction;
- Filing and entering an award under the Workers' Compensation Law;

- Filing an affidavit of publication of notice of dissolution of partnership;
- Filing an appeal of a determination whether a dog is potentially dangerous or vicious under the Food and Agricultural Code;
- Filing an affidavit under § 13200 of the Probate Code, together with the issuance of one certified copy of the affidavit under § 13202 of the Probate Code; and
- Filing and indexing all papers for which a charge is not elsewhere provided, other than papers filed in actions or special proceedings, official bonds, or certificates of appointment.
